Minutes of the meeting of CEC of the Association

The 6th meeting of the Central Executive Committee constituted for the year 2017-2019 was held on 24th March'2018 at Vidyut Bhawan inviting all members.

Sri Dipak Saha, President of the Association presided the meeting.

At the very beginning Sri Chiranjit Ghosh, Office Secretary read out the minutes of the last CEC meeting and the minutes was accepted by the house unanimously.

Then Agenda wise discussion was started.

Sri Rana Bandyopadhyay, General Secretary of the Association informed the house about recent activities of the Association which are stated below:

- The Central Committee members met separately with all five Zonal Committees of the Association during this period and discussion were held therein regarding various issues. GS also informed that meeting with all PDCL Unit Committees shall be held in due course.
- One transfer order was issued by the PDCL management transferring some members of the Association belongs to F&A wing of WBPDCCL where two members felt difficulties to join in their future assignment due to some personal ground. Association took-up the matter with Director (HR), WBPDCCL & Director(RA), WBPDCCL and assurance received from both Directors of WBPDCCL to look into the issues of transfer of both the lady officers.
- The Association requested for extension of release of time upto 31.03.18 of Safety Officers posted at various Zones of WBSEDCL following their transfer, the management of WBSEDCL accepted the request of the Association and extends the date of release up to 31st March'2018.
- The GS informed the house that in response to the meeting called by the Department of Power & NES, Govt. of West Bengal held on 29.01.18, WBSEBOA & other two Associations (WBSEBEA & WBSEBFMA) attended the meeting and informed the representatives of the Power Department that the ratio of consideration for calling in the interview process should be 1:3 ration in case of beyond CPS promotion as per existing policy of the Company as well as in vogue at other power utilities under Govt. of West Bengal.

- The GS also informed the house that similar necessary steps shall be taken by the three Associations jointly towards release of DA & issuance of Committee report constituted under the Chairmanship of Director(F&A), WBSEDCL towards promotional track of all Class-I officers vide Office Order No.833 dated.19.05.14.

Sri Indranil Banerjee raised his concern towards non release of DA to all employees of the three organizations by the management of WBSEDCL, WBSETCL & WBPDCCL. He also told that previously “Cash Flow Statement” was circulated among the stakeholders of the Company to inform the financial health of the Organization but now the same has apparently been stopped. He also told that previously Joint Management Council meeting use to be held at regular interval, however the same was not organized in the last six to seven years which needs to start again for maintaining of harmonious industrial relations. He requested the GS to take-up the issue with Competent Authority of WBSEDCL.

Smt Madhulika Banerjee informed the house about recent activities of the Study Group. She told that total 09(nine) no. of PPTs were received from members of the Association so far and initial nurturing has been completed by the Study Group for all those PPTs. The GS informed that the proposed Panel discussion will be arranged within May'18.

The President of the Association proposed that one report may be asked from all Zonal Secretaries of the Associations towards present status of collection of subscription from the members.

The Office Secretary read out the names of the members of the Association whose transfer applications were received by the Association. The GS informed the house that among all application Association already made communication to the Director (HR) of WBSEDCL & WBSETCL with some of the cases on preference basis.

The meeting ended with the vote of thanks to the chair.
